Pat Straka Joins Executive Board

Greetings let me introduce myself, my name is Patrick (Pat) Straka. My journey started with A.C.T. in 2007 when I became a technician. I started as a Tools and Parts attendant for FMS 15-A PAARNG TMP. One day I came back from parts run and fellow crew was on break, back in our little break room. They said Hey you would make a great shop Steward, and run our office fund (snack bar). I said sure what do I do? The then retiring Steward Steve said I will show you; it is easy. Thereafter I started at the lowest level and began my career with A.C.T. Then in 2016, I was approached by the State Council to become the Treasurer. Because I was thorough in my work. So, in 2017 I was elected to the board as State Council Treasurer and went to work cleaning up the coffers preparing for the next generation of members of the Board, and making sure we had proper procedure in processing DOL tax forms and audits of the Chapters. I then continued up the ranks to VP, EVP, and finally Chairman of the State Council. I also served as Chapter president for Blue Mountain Chapter 46 until I trained a replacement for the role. I served on negotiation teams for CBA negotiations and as Chairman I served as lead contract negotiator during COVID-19 and those Challenges. I Sit on my State level Safety Council for all employees, I sit on the Tennent Board to keep track of building projects and how they will change work conditions, and I conduct quarterly meetings with the DAGS to address trends and apprise them of concerns of the workforce. I have volunteered to learn and to be part of the FPRAC committee. I will leave you now to get back to the important work you all do as part of our collective which makes up the strength of our team!


