As of March 1, 2018 The Election Committee will begin accepting Nominations for the positions of National:

Only written nominations will be accepted electronically. All nominations must be date stamped by the e-mail server not later than April 15, 2018. To be eligible for office a nominee must have been a member in good standing and on the membership rolls since July 1, 2017.

When submitting your nomination, include the name / home mailing address / chapter name and number



/ e-mail address of the nominee as well as your name / home mailing address / chapter name and number / e-mail address. This complete information is necessary in order to validate the nomination. Failure to provide this information could result in a nomination not being validated. Prior to submitting your nomination, it is advisable to confirm that the individual is willing to accept the nomination.


